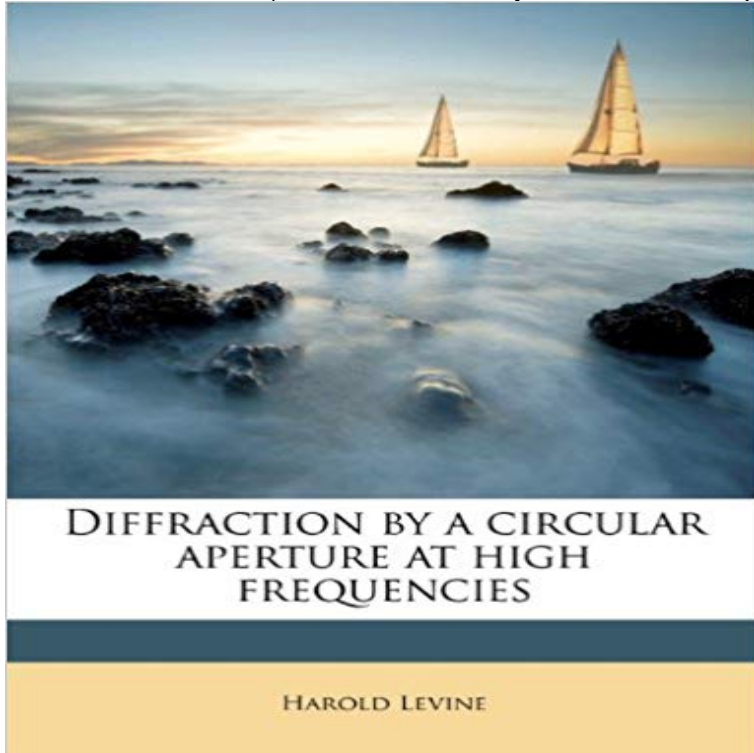


Diffraction by a circular aperture at high frequencies
